Scheduling — All consultations are scheduled based on mutual agreement between Deborah and me. To schedule a session, **payment is required in advance**. After payment is made, Deborah will contact me to make the appointment. Consultations must be scheduled within 30 days of payment. The appointment does not have to occur within 30 days, but the scheduling of the consultation must occur within 30 days of payment. To make a payment, choose the appropriate PayPal button at <http://internalwilderness.com> . PayPal accepts all major credit cards. You do not need a PayPal account to use PayPal.

Rescheduling — Consultations can be rescheduled when a date and time can be found that satisfies both me and Deborah. If I need to reschedule, I'll contact Deborah at least 48 hours prior to my scheduled appointment. If Deborah needs to reschedule, she will contact me according to my preferred method 48 hours prior to our scheduled appointment. If a new appointment time that meets both my and Deborah's schedules cannot be found, my payment will be refunded.

Short Notice Rescheduling — If I need to reschedule the appointment less than 48 hours before our scheduled time, I forfeit 50% my payment and will be re-billed before the appointment can be rescheduled. If Deborah needs to reschedule less than 48 hours before our scheduled time, Deborah will provide a future 30 minute Follow-Up Consultation for no charge. Those appointments will be rescheduled without delay.

Cancelling — no refund will be issued if I cancel the appointment and do not reschedule at the same time that I cancel.

Late Arrival to Call – Deborah will arrive 5 minutes early for your call and stay on the line for 15 minutes, total. If you have not arrived within the first 10 minutes of your session, this will be construed as **“Failure to Show”**

Failure to RSVP /Failure to Show — no refund will be issued if I fail to promptly RSVP to the final scheduling email, if I fail to promptly notify Deborah that I did not receive it, or if I do not show for the scheduled appointment.

Follow-up Consultations – After any GPS session, I can schedule a Follow-Up Consultation with Deborah for up to 30 minutes for \$65. These sessions can be scheduled up to once per month. **If my first session with Deborah is the result of a special offer, I am only entitled to one Follow-Up Consultation until I become a regular client.**

Predictions that don't come true will receive no refund for the session in which the prediction was offered.
